

**Town of Woodstock
Selectmen's Meeting
Tuesday, May 2, 2017**

Joel called the meeting to order at 6:30 p.m. Jim seconded the motion and the vote was affirmative.

Public Participation:

Charlie Wishart/Driveway:

Charlie Wishart approached the Board looking for guidance pertaining to the relocation of a storm drain and enlarging his driveway. The Board directed Charlie to work the details out with the building inspector and the road agent.

Myles Moran/Waterline/Lost Valley:

The Board reviewed a plan relating to a waterline extension. Jim explained that Myles had originally presented this plan for approval back in April of 2004 but was unable to complete the project. The plan reflects a connection to the town's watermain along Lost Valley Road to Myles property located on Snow King Road, Map 104 Lot 035. The Board agreed to allow the water connection so long as Myles runs a 6-inch line across the road to a hydrant that will be provided by the Town. Tap fees will be addressed at a later date.

John Payne/Inn 32/Sidewalk Maintenance:

John Payne, owner of Inn 32, explained that Inn 32 is now opened in the winter and asked the Board to considering maintaining the sidewalk in front of the Inn. The Board directed John to meet with the road agent to work out the logistics.

Application/Cascade Park/Stephanie Morris & Aaron McLeod:

The Board reviewed a letter from Stephanie Morris and Aaron McLeod asking that they reconsider the decision to deny their wedding at Cascade Park on October 1, 2017. They explained that they had submitted their order for wedding invitations last week and did not worry that the application would be denied as it seemed as this was usual process for ceremonies for weddings at Woodstock, Inn, Station, & Brewery. Jim motioned to make a onetime exception and approve the application. Joel seconded the motion and the vote was affirmative.

Woodstock Inn Brewery Analysis:

The Board reviewed analysis, prepared by Horizons Engineering, pertaining to the Woodstock Inn Brewery for the month of March. Based on the analysis Joel motioned to abatement \$1461.00 from the March billing. Jim seconded the motion and the vote was affirmative.
