

**Town of Woodstock
Selectmen's Meeting
Tuesday, July 11, 2017**

Joel called the meeting to order at 6:32 p.m. Gil seconded the motion and the vote was affirmative.

Public Participation:

Michael Donahue/Demolition:

Mike questioned the building permit process and requirements for the demolition of a mobile home.

Michael Donahue/Sludge Removal:

Mike asked how much it costs to remove sludge from the sewer treatment plant. Mike requested a print out for the last 4 years.

Minutes of the June 27, 2017 Meeting:

Jim motioned to accept the minutes of the June 27, 2017 Selectmen's Meeting. Gil seconded the motion and the vote was affirmative.

Minutes of the June 27, 2017 Non-Public Meeting:

Jim motioned to accept the minutes of the June 27, 2017 Non-Public Selectmen's Meeting. Gil seconded the motion and the vote was affirmative.

July 1st Flood Damage/FEMA:

Discussion was had pertaining to the damage caused during the July 1st flooding. Jim reported that we have 5 areas of concern:

1. Sellingham Hill Road washout. Ditch, culvert, and road repair needed.
2. Main sewer line groundwater infiltration. Location to be determined by camera inspection. Suspect it is in the river.
3. Main sewer line river crossing exposure at Town Garage. (Excavation and Rip Rap needed)
4. Main sewer line river crossing exposure at Sewer Treatment Plant (Excavation and Rip Rap needed)
5. Main sewer line river crossing exposure behind Main Firehouse (Excavation and Rip Rap needed)

These damages have been submitted to our insurance company as well as to FEMA for review. There is concern about the groundwater infiltration. Jim made a motioned to hire someone to scope the sewer line. Gil seconded the motion and the vote was affirmative.

Application/Cascade Park/Fitzemeyer:

The Board reviewed an application from Lauren Fitzemeyer to use Cascade Park on August 5, 2017 for a wedding ceremony. The required fee and insurance coverage has been received. Jim motioned to approve the application. Gil seconded the motion and the vote was affirmative.

Old Business:

New/Other Business:

Joel notified the Board of a complaint that he received from Ashley and Ryan LaRue pertaining to their sign that Mike removed at Cascade Park. Ashley and Ryan reported damage to their sign and feel it was caused due to the reinstallation. Joel presented the Board with the pictures that were sent to him. The Board will look into it.

Joel motioned to adjourn the Selectmen's Meeting at 7:30 p.m. Jim seconded the motion and the vote was affirmative.
