Call to Order

Charyl called the meeting to order at 5:00 pm.

Approve & Sign Joint Minutes/January 19, 2022

Scott motioned to accept the minutes of January 19, 2022, Joint Selectmen's Meeting. Gil seconded the motion, and the vote was affirmative.

Approve & Sign Minutes/January 25, 2022

Gil motioned to accept the minutes of January 25, 2022, Selectmen's Meeting. Scott seconded the motion, and the vote was affirmative.

Approve & Sign Workshop Minutes/January 28, 2022

Scott motioned to accept the minutes of January 28, 2022, Selectmen's Workshop. Charyl seconded the motion, and the vote was affirmative.

Workshop Recap

Charyl noted that the Board met with Ben Clark on February 15th to discuss the water main leak located by the on-ramp for I-93 South and possible solutions. Charyl stated the water main is currently shut off, and the Board will reevaluate in the Spring when the ground thaws. Scott noted that this appears to be the big leak and stated that Mike

has already seen a difference in the run time at the wells. Gil said that the Town would not be charging the Clark Family the base rate until water access is re-established. Gil also pointed out that Ben was very willing to work with the Town on the repair cost.

Scott/Asset Management Grant

Scott stated that the Town has received roughly \$90,000 from the Water Asset Management and Equipment grant and noted that he is currently working on the Sewer Asset Management and Equipment grant, which is due in March.

Scott is hopeful that the Board can develop a ten-year CIP plan for water and sewer with these grants.
