Public Hearing

Charyl called the public hearing to order at 4:45 pm.

Charyl explained that pursuant to RSA 31:95-b, a noticed public hearing was necessary to take public comment on the accepting and expending of unanticipated revenue from an NHDES Wastewater Asset Management Grant.

The Town received \$30,000 to develop an asset management program for the wastewater system.

Charyl opened the floor to public comment.

The public hearing remained open for 15 minutes with no public comments.

Appoint/Clifford Ayotte/Cemetery Trustee

Charyl motioned to appoint Clifford Ayotte as a Cemetery Trustee. Gil seconded the motion, and the vote was affirmative. Clifford took his Oath of Office.

Approve & Sign Minutes/May 31, 2022

Gil motioned to accept the minutes of the May 31, 2022, Selectmen's Meeting. Charyl seconded the motion, and the vote was affirmative.

Russell Farm Road

The Board opened one sealed bid for Russell Farm Road:

The Board opened one sealed bid for Town Office Parking Lot:

- GMI Industries- \$23,400.00

Gil motioned to award the bid to GMI Industries. Charyl seconded the motion and the vote was affirmative.


