Jim called the meeting to order at 6:30 p.m. Gil seconded the motion and the vote was affirmative.

**Committee Assignments:**

Jim motioned to maintain committee assignments and department liaisons the same with the exception of adding the Fire Department to Gil Rand. Gil seconded the motion and the vote was affirmative.

Steve requested an expenditure of \$3500 to have the water tank cleaned and inspected. It has been five or six years since the last cleaning and inspection. Joel motioned to approve this expenditure. Gil seconded the motion and the vote was affirmative.
