## NOTICE OF PUBLIC <u>BOND</u> HEARING AND PUBLIC HEARING ON <u>PROPOSED BUDGET & WARRANT ARTICLES</u>

To the residents of the Town of Woodstock, in Grafton County, State of NH

Notice is hereby given of a Public Hearing to be held on Wednesday, February 8<sup>th</sup>, 2023 at 5:00pm for the purpose of a proposed warrant article to see if the Town will vote to raise and appropriate the sum of Five Hundred Nine Thousand Two Hundred Eight Dollars (\$509,208) for the purchase of a Fire Department BullDog Fouts Brother's 3000 Gallon Tanker Truck and to authorize the withdrawal of Two Hundred Thousand Dollars (\$200,000) from the Fire Truck Capital Reserve Account created for that purpose, further to authorize the issuance of not more than Three Hundred Nine Thousand Two Hundred Eight Dollars (\$309,208) of bonds, notes, or lease agreements in accordance with the provisions of the Municipal Finance Act (RSA Chapter 33) and to authorize the Board of Selectmen to issue and negotiate such bonds, notes, or lease agreements and to authorize the Selectmen to apply for, accept and expend any grants available for this purpose. Payments begin in 2025.

This bond will be voted, by ballot, on Town Meeting Day Tuesday, March 14<sup>th</sup>, 2023.
